## COMMITTEE OF COMPANY SIGNATORIES TO THE OFFSHORE DIVING INDUSTRY AGREEMENT (ODIA) WORKFORCE UPDATE – DECEMBER 2014

## **Diver Competency/Pay Grading Matrix**

Following the implementation of the Diver Competency/Pay Grading Matrix on the 1<sup>st</sup> November 2014 we received some concerns from the workforce, which we've listened to, discussed with the RMT and ratified at the Signatory Meeting last week. The Signatories and the RMT have agreed to push on with the implementation and deal with any cases as they present themselves on an individual basis.

The Diver Pay Grading workgroup was formed following a request by the RMT for the Signatories to address the issue of inexperienced Divers receiving Professional Diver pay. The Matrix was implemented on the 1st November 2014 for new divers and will not be implemented until the 1<sup>st</sup> November 2015 for all existing divers. This will allow all existing divers 1 year to complete all the required paperwork, in their company's competency scheme, have it checked by an ODIA Signatory Company and be issued with a Certificate of Professional Diver Pay Grading. Transient workers, without a specific company competency scheme can use the IMCA competency scheme, which is recognised by all the Signatory Companies.
